ORDER

Sub: Regarding applicability of Tariff on Hostels.

As per tariff order dated 20.02.2015(effective from 01.02.2015) issued by RERC, only Hostels run by the Government/ Government recognised Educational Institutions/Registered Charitable Institutions are covered under Domestic Services and all other Hostels are covered under non-domestic category. Presently, large number of Hostels are being run by private institutions/ individual persons also are being billed in Domestic Category as per old criteria. Now, as per new criteria of retail Tariff Order dated 20.02.2015, such Hostels run by private institutions/ individual persons are covered under Non-Domestic Category and to be billed accordingly.

To make aware to the consumers for this new provision of applicability of Tariff for use of their electric connection for Hostel purpose, sub-divisional office will issue a notice of 15 days in the format enclosed at Annexure "A", to such identified Hostels which are presently being billed under Domestic Category for applying for change of category of their electric connection from Domestic to Non-Domestic or for separate electric connection for Hostel under NDS Category.

In case no such request is received from the consumer after expiry of notice period and on checking the premises, if found using for Hostel purpose, necessary action will be taken under the provisions of malpractice under section 126 of Electricity Act-2003 and as per the various guidelines issued by Nigam time to time.

Sub : Applicability of Tariff on electric connection used for Hostels.

The electric connection bearing account No. ----- is being used for Hostel purpose also and presently being billed under domestic category. As per retail Tariff order of RERC dated 20.02.2015 (Effective from 01.02.2015) Hostels run by Govt./Govt. recognized educational institutions and registered charitable trust are only covered under domestic category and all other Hostels are covered under non-domestic category.

You are therefore, advised to apply for change of category of your electric connection from domestic category to non-domestic category if being utilized for Hostel purpose, within a period of 15 days from this notice, or take a separate connection under NDS category for use of Hostel purpose, so that the billing may be done accordingly. Please note that in absence of above confirmation, if after expiry of notice period, during checking if electricity is found using from domestic connection to Hostel purpose then the same shall be treated as unauthorized use of electricity for which misuse charges shall be leviable beside disconnection as per Rules/Act.
