

Sub:- Applicability of provisions of ESI Act 1948.

The Ministry of Labour & Employment, Government of India, vide its Notification dated 20.7.16 & 9.8.16 made applicable provisions of Chapter-IV, V & VI (except Sections which already brought into force) of the Employees State Insurance Act-1948 w.e.f. 1.8.16 & 1.9.16 respectively. Vide these Notifications, complete area of all Districts falling under the jurisdiction of JVVNL are now covered under the said Act. Further, vide Notification dated 22.12.2016, the wage ceiling for coverage of employees under ESI Act has been revised from Rs. 15,000 per month to Rs.21,000 per month w.e.f.1st January,2017.

Some of the units/offices of JVVNL are already covered under the ESI Scheme, whereas the offices which are situated in the area where the ESI has been made applicable first time, as per aforesaid Notifications, have to get registration under the ESI Scheme. As per Reg.10-B of Employees State Insurance(General) Regulations, 1950, such establishments to which the Act applies for the first time and to which, an Employer's Code Number is not yet allotted, has to furnish a declaration of Registration in writing in Form 01 and Form 01-A, within a period of 15 days after the Act becomes applicable. It has come to the notice that some of the Unit Offices have not yet applied for registration with the Local/Regional Office of ESI, as per above procedure. In case of non-registration of establishment and consequently non-payment of ESI Contribution, the ESIC may claim arrears and also recover the same by attaching bank account of the Nigam.

Insurance Commissioner(P&D), ESIC, New Delhi has informed vide Notice dated 20.12.16 that ESIC in its 170th meeting held on 15.12.16 has approved a Scheme to promote registration of Establishments/Factories and employees coverable under the ESI Act 1948, under which, if the Establishment/Factory is registered upto 31st March,2017, the same will be treated as covered from the date of registration. You are, therefore, requested please to ensure registration of office(s) and employees under your jurisdiction under ESI Scheme, as per Rules immediately, if not already registered, with the assistance of DDP/PO & Sr.AO/AO concerned and in consultation with Local/Regional Office of ESIC.
