Sub :- Grant of Dearness Relief to the Pensioners of Nigam.


In exercise of the powers conferred vide order No. JPD/CAO/F.246 / D.4221 dated 11.12.2001, the Chairman & Managing Director has been pleased to adopt the State Government's order No. F.12 (4)/FD (Rules)/ 2008 dated 27.2.2009 and the existing rate of Dearness Relief payable to the Pensioners as mentioned in Annexure-"D" appended with order No.RVPN/AS/GAD/F&R/Pension/ D.1251 dated 01.10.2008 [endorsed vide order No. JVVNL/Sr.AO(HQ)/AAO(Rules)F.176/ D.1613 dated 01.10.08 (JPD/Rules-500)] shall be revised from 16% to 22% w.e.f. 01.01.2009.

The provisions of this order shall also be applicable to the pensioners of erstwhile RSEB.

The amount of Dearness Relief at increased rates for the month of March,2009 and onwards shall be paid alongwith Pension for respective month.

The amount of Dearness Relief from 01.01.2009 to 28.02.2009 (two months) shall be paid alongwith pension for the month of April,09 (payable in May,09).
