No. F.8(2)FD(Rules)/2008

Jaipur, dated: **27 JAN 2009**

Subject : Grant of Compensatory (City) Allowance to Government servants.

The Governor is pleased to order that the existing Rule 2 alongwith Note thereunder shall be substituted by the following, namely -

"2. **Definitions :** For the purpose of these rules, "Basic Pay" means pay in the Running Pay Band and Grade Pay admissible under Rajasthan Civil Services (Revised Pay) Rules, 2008.

Note : In the case of employees who are drawing pay in the scales of pay which prevailed prior to 01.09.2008, the basic pay in the pre-revised pay scale will include amount of Dearness Pay appropriate to that basic pay.

Clarification

During the period from 01.09.2008 to 31.08.2008, Compensatory (City) Allowance is admissible at the rates in force prior to 01.09.2008 on the pay in the existing pay scale. In other words, for the aforesaid period no arrears on account of Compensatory (City) Allowance is payable."

The Governor is also pleased to order that the existing rate of Compensatory (City) Allowance admissible under FD Order No.F.1(32)FD(Gr-2)/78 dated 06.07.1995 to the State Government servants posted at Hyderabad (UA), Delhi (UA), Bangalore (UA), Greater Mumbai (UA), Chennai (UA) and Kolkata (UA) may be revised as under -

S. No.	Basic Pay i.e. total of pay in the Running Pay Band and Grade Pay	Rate of CCA (p.m.)
1.	Employees drawing Basic Pay upto Rs.7000/-	180/-
2.	Employees drawing Basic Pay above Rs.7000/- but upto Rs.10000/-	250/-
3.	Employees drawing Basic Pay above Rs.10000/- but upto Rs.13000/-	400/-
4.	Employees drawing Basic Pay above Rs.13,000/-	600/-

This order shall be deemed to have come into force with effect from 01.09.2008.

MEMORANDUM

No. F.1(1)FD(Rules)2005

Sub. :- Fixation of pay in the Rajasthan Civil Services (Revised Pay) Rules, 2008 of person whose increments have been with-held or whose pay has been reduced as a measure of penalty.

The undersigned is directed to state that the pay of Government servants who have exercised option to come over to Revised Pay with effect from 01.09.2006 under Rajasthan Civil Services (Revised Pay) Rules, 2008 but were drawing reduced pay on the date as a result of some penalty with a provision for restoration of their pay on the expiry of the period of penalty e.g. stoppage of increments without cumulative effect and reduction to a lower stage in the time scale without cumulative effect should be fixed both:-

- (a) on the basis of pay actually drawn on 01.09.2006; and
- (b) on the basis of pay which would have been drawn but for the penalty.

The revised pay as fixed at (a) above may be allowed from 01.09.2006 to the date of expiry of the period of penalty and the revised pay fixed as in (b) above from the date following the date of the expiry of the period of penalty after allowing increments, if any, that might have notionally fallen due in the revised pay during the period from 01.09.2006 to the date of the expiry of the period of penalty.

In cases where a Government servant opts for the revised pay scale from a date subsequent 01.09.2006 as per Rule 23 of Rajasthan Civil Services (Revised Pay) Rules, 2008, pay fixation shall be done on the same lines as indicated above from the date of option instead of 01.09.2006.

Subject: House Rent Allowance Rules.

The Governor is pleased to order that the following amendments shall be made in the House Rent Allowance Rules, namely: -

In the said rules -

- (a) the existing sub-rule (1) of Rule 2 alongwith Note thereunder shall be substituted by the following, namely -
- (1) 'Basic Pay' means total of pay in Running Pay Band and Grade Pay admissible under the Rajasthan Civil Services (Revised Pay) Rules, 2008.

Note: In the case of employees who are drawing pay in the scales of pay which prevailed prior to 01.09.2008, the basic pay in the pre-revised pay scale will include amount of Dearness Pay appropriate to that basic pay.

Clarification

During the period from 01.09.2008 to 31.08.2008, House Rent Allowance is admissible at the rates in force prior to 01.09.2008 on the pay in the existing pay scale. In other words, for the aforesaid period no arrears on account of House Rent Allowance is payable."

- (b) In existing sub-rule (2) of Rule 5 under heading "Cities classified as 'Y'" after existing S. No. 4, the following shall be inserted at S. No.5, namely -
- "5. Ajmer (U.A.)"

This order shall be deemed to have come into force with effect from 01.09.2008.
