

NOTIFICATION


In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Compassionate Appointment of Dependants of Deceased Government Servants Rules, 1996, namely:-

1. **Short title and commencement.**- (1) These rules may be called the Rajasthan Compassionate Appointment of Dependants of Deceased Government Servants (Amendment) Rules, 2008.
(2) They shall come into force with immediate effect.
2. **Amendment of rule 2.**- The existing clause (b) of rule 2 of the Rajasthan Compassionate Appointment of Dependants of Deceased Government Servants Rules, 1996 shall be substituted by the following, namely:-

"(b) " Deceased Government Servant " means a person who was employed in connection with the affairs of the State including a member of All India Services of Rajasthan State Cadre and whose pay was debitable to the consolidated fund of the State and who died while in service and, who was:-

 - (i) Permanent, or
 - (ii) holding a post temporarily after appointment on regular basis and had put in at least three years continuous service including period of probation as probationer-trainee."
